
The website will serve as a training tool for African notaries by hosting several publications and online courses.

Meeting between judges and notaries on *Dejudicialisation*

As complementary public authorities, Judges and Notaries met in Barcelona, on October 21th and 22th of 2022, for a joint workshop between the International Association of Judges (IAJ) and the International Union of notaries (UINL), organized by the European Notarial Academy and the European Affairs Commission (CAE), on the theme of Desjudicialisation.

In a context of "contractualisation" of law and desjudicialisation, Notaries must assume now, more than ever, the role of "out-of-court magistrates" and take on new tasks which were, until now, within the Court's jurisdiction.

A productive dialogue was carried out about the opportunities and limits of this transfer of competences.



World Notariat University "Jean-Paul Decorps" End of the cycle 2020-2022 and beginning of UNM 2023-2025

The three-year training cycle promoted by the World Notariat University for young notaries across the world ended with the 30th International Congress of notaries, which took place from December 1st to December 3rd 2022.

The University, created by French notary Jean-Paul DECORPS in 2012, celebrated its 10th anniversary in Cancun (Mexico). The event allowed Profesors and students to meet in person, after 2 years of pandemic.

As a "laboratory for the Notariat of tomorrow", the University is a place for dialogue and teaching for the future. In that way, the training cycle 2020-2022 was organized around the transversal

theme "The notary: a protagonist for legal security in civil law: Protection of the citizen - Protection of society" and through three sub-themes: "Reaction and adaptability of the notarial function in the context of the pandemic" (2020), "The notarial function and the notarial authentic instrument in a digital context" (2021), "Function of notaries 4.0" (2022).

To conclude the training cycle and highlight the connection between Notaries and Universities, the four Professors (Not. Dra. Cristina Armella from Argentina, Pr. Christine Morinfrom Quebec, Pr. Luc Weyts from Belgium, and Pr. Michel Grimaldi form France) chose several laureates, among the students from the last editions, to participate in the round-table and present the result of their work.

The next edition of the WNU will start during the first semester of 2023 and will end with a closing weeklong workshop, which is set to take place in Rome (Italy).

The working group recently created by President Cristina ARMELLA met virtually on Wednesday 9th 2022 to discuss women's rights and gender equality.

Among its missions, the Group identified the first women notaries in each Member Notariats and analized the Convention on the Elimination of All Forms of Discrimination against Women.

The Working group also collaborates with UN WOMEN and UNICEF programs about protection of women and girls with disabilities.

Conclusions of the group will be presented on International Women's Day, on March 8th 2023.

The General Meeting and the General Council approved the guide for risk assessment (BC/FT) in the notarial sector provided by the Working group "Prevention of money-laundering".

The purpose of this document is to establish a methodology and criteria in order to facilitate the Self-Regulatory Bodies or each Notarial Council member to carry out a risk assessment of the notarial sector in their country.
